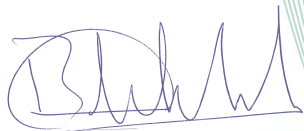

Resistance to ignition by glow wire temperature: insulation material around connections within an area of 3,0 mm

- Glow-wire test 750 °C; no flame

- Glow-wire test 850 °C; flame, if any, extinguished within 30 seconds after removal of the glow-wire tip.
